## Our Program

The Detox Program consists of introducing information on substance abuse in a group setting on a daily basis. Factual information is presented through videos and group sessions. Group sessions are designed to assist the client to understand the process of addictions, first steps into recovery and preparation for treatment.

While at Foothills Centre, clients will have access to the Program Coordinator for referral to further treatment or discussion on any issues they may have. Clients are also assisted with discharge planning, relapse prevention and support resources.

## Detox Program Admission Criteria

Must require detoxification from alcohol and/or other drugs.

A phone interview with our staff is required before all admissions.

Attend scheduled self-help meetings.

Attend daily group sessions.

Abide by resident requirements.

## Other Services

Short term relapse prevention is offered to those feeling at risk. This service is for people who have had some length of sobriety or non use but are feeling vulnerable to relapse. Usually a two to three day stay is enough to help a person refocus on their recovery. Individuals may also utilize our services for a pretreatment 5 day stay before attending a residential treatment program. This service must be booked in advance

Support services are available on an outpatient basis, past clients or community members may attend group lectures upon request. We also provide, by appointment, support and information to family members going through a crisis within their family unit.

Closed 12-step meetings are available for members. Please phone for schedule.
